DECLARATORIES

- A. 2020 INTERNATIONAL is an International Association of Independent Accounting and Consulting Firms, based in:

- B. UC&CS GLOBAL is an International Association of accountants, lawyers and business advisors, based in:

- C. Both Associations have similar aims.
- D. They wish to work together but not so as to form any legally binding relationship.
- E. They wish to record by this document how they intend to work together as follows:

TERMS OF THE CONTRACT

1. Where one of the Associations has work in a jurisdiction where it is not represented to use the other Association to ask its member where that work is to recommend someone to do that work. If it is legal work the recommendation will be to an appropriate law firm or if it is accountancy and audit work it will be to an appropriate accountancy firm and where appropriate both a legal and an accountancy firm. Same apply to business advisory work.  
When both Associations have a Member in the same country or city, preference will be given to internal Members, before requesting support from Alliance Associate or Member.
2. The signatories cannot be held liable for the actions of each of their members
3. The signatories shall refrain from entering into any financial relations between the members of both organizations

4. To attend, if convenient and only by specific invitation, one another's meetings, particularly General Meetings, as appropriate, with a view to making presentations at such meetings and networking. To consider joint training sessions and attending each other's training sessions, if convenient and only by specific invitation.
5. To share written material, including publications and statistical information of International Accounting Magazines, recognizing the other Association.
6. The Alliance is established as exclusive only for reporting the information to International Accounting Magazines, but leaving each party free of having Members or Alliances in any country of the World, subject to Clause 10.
7. To announce the Strategic Alliance in both websites of each Association, as follows:

In the Strategic Alliances Area of both websites, it will be included a link to the other counterpart's website. It won't be included a listing of individual firms in counterpart's site, merely highlighting that an alliance is in place.
8. To work together in order to enhance the relationship between the two Associations, but always having regard to D. above, including carrying out such other activities as may be conducive to working together in accordance with the spirit of this Strategic Alliance Contract.
9. Each signatory shall nominate his representative and inform the other party  
Thereof:

2020 INTERNATIONAL nominates Ian Fletcher, Managing Director, and  
UC&CS GLOBAL nominates his President, Mauricio Mobarak.
10. The term of this agreement shall be one year renewable for further terms of one calendar year by tacit agreement every year.

Each party may cancel this agreement subject to a written notice period of 60 days in advance of the date of termination.

This contract is the entire agreement between the Associations and supersedes any prior agreements, oral or written, and rescinds any previous offers, promises or agreements. The parties are bound to each other only by the terms contained in this writing and any subsequent writings signed and agreed to heretoforth.
